# Florida Legislation 2024 is in full Gear!



SB 7000 builds on the deregulation of public schools. A few highlights that may directly impact exceptional student education include: Allowing prekindergarten instructors 30 days after hire to complete the required emergent literacy courses, specifying that a teacher certified in exceptional student education is considered in-field if he or she is teaching exceptional students in a self-contained classroom (currently, self-contained ESE certified teachers are only considered in-field when teaching Access), and establishing a 10-year renewable professional certificate for teachers rated highly effective in 4 years of the 5-year validity period of their professional certificate. The hope is these changes enable districts to increase success in recruiting and retaining teachers.

Under SB 7000, a proposal has been made to: waive initial subject area examination fees and certification fees for a teacher who holds a temporary or professional certificate in: (a) Exceptional Student Education K–12 and who applies to add a subject coverage in Elementary Education K–6. (b) Elementary Education K–6 and who applies to add a subject coverage in Exceptional Student Education K–12.

No later than December 1, 2024, the Commissioner of Education will be making recommendations to the Governor and Legislature on policy and funding changes to assist in the development and retention of ESE instructional personnel. The commissioner will be considering

- (1) Alternative certification in place of the Elementary Education K-6 certificate as an add-on for personnel certified in exceptional student education.
- (2) Financial incentives, including stipends for teacher education students, loan forgiveness, and instructional personnel salary adjustments and supplements.
- (3) Strategies to encourage high school students to consider exceptional student education, including through pre-apprenticeships and dual enrollment.
- (4) Funding under the Florida Education Finance Program to support school district exceptional student education personnel and programs.
- (5) Innovative staffing, including teacher mentoring and supports for certified personnel responsibilities for case management and for instruction.

CS/SB 7002 removes requirements for school boards to provided and annual report on district guidance services. This report is no longer necessary as district school boards provide the information in their annual Mental Health Assistance Allocation Plan and the Mental Health Assistance Allocation Outcomes and Expenditures Report.

CS/SB 7004 creates an additional good cause exemption from third-grade retention to specify that a parent may determine promotion to grade 4 is in the best interest of the student, provides that students will not be required to pass the Algebra 1 end-of-course assessment and grade 10 ELA assessment to earn a standard high school diploma, and removes the requirement for administration of the common assessment for students in DJJ prevention, residential, or day treatment programs.

Senate Bill 4C and House Bill 3C, removes the cap on vouchers for special needs students in the Family Empowerment Scholarship for Students with Unique Abilities program. This is an attempt to accommodate the 8,000+ students who are on a waiting list for the voucher. This proposal only applies to the current school year. Beginning in 2024-25, the maximum number of students in the voucher program would increase annually by 3% of the exceptional student education full-time equivalent student membership.

Our primary focus should remain fully funding special education after years of grossly inadequate funding by our government. The IDEA Full Funding Act is discussed yearly and our representatives need to know we, as educators, expect their support.




# A Tribute to Dr. Martin Luther King Jr.



Today, we remember the life and legacy of Dr. Martin Luther King Jr., an American Baptist minister and activist who played a key role in the American civil rights movement from the mid-1950s until his assassination in 1968. He was a prominent leader who advanced civil rights for people of color in the United States through the use of nonviolent resistance and nonviolent civil disobedience against Jim Crow

laws and other forms of discrimination in the United States. King participated in and led marches for the right to vote, desegregation, labor rights, and other civil rights, He oversaw the 1955 Montgomery bus boycott and later became the first president of the Southern Christian Leadership Conference (SCLC). As president of the SCLC, he led the unsuccessful Albany Movement in Albany, Georgia, and helped organize some of the nonviolent 1963 protests in Birmingham, Alabama, King was one of the leaders of the 1963 March on Washington, where he delivered his "I Have a Dream" speech on the steps of the Lincoln Memorial, and helped organize two of the three Selma to Montgomery marches during the 1965 Selma voting rights movement. The civil rights movement achieved pivotal legislative gains in the Civil Rights Act of 1964, Voting Rights Act of 1965, and the Fair Housing Act of 1968. Dr. King's contributions to the civil rights movement have left an indelible mark on American history and continue to inspire people around the world to fight for justice and equality.
